1)EPX Table @ 10/5/08 St. Nick's Festival ñ Lots of participation by Board members in staffing table. About 25 new EPX signups.

2)11/7/08 EPX Art Auction ñ Last EPX fundraiser of the year. \$20 per ticket. Food to be provided by Paradiso, Le Virtu, Mamma Maria; beer by Reading Beer. Banners will be displayed across East Passyunk Ave.

4)Fall newsletter almost complete. To be hand-delivered, not mailed, thus decreasing EPX distribution cost.

Thanks to EPX member Pat Corteza for working at reception table tonight.

No new signups tonight.

Approximately 25 new signups at St. Nick's Italian Festival.

EPX membership around 300; not all are active (or voting) members, however. Jack Morley, Republican candidate for State of PA First District in attendance; available to talk to interested attendees after meeting.

Public Safety ñ M. Damis

Participation in Town Watch walks has been decent lately.

Will get Town Watch flashlights and hats through Police Dept.

Working on spreading word among neighborhood residents about importance of keeping outdoor lights on, which greatly deters criminal activity. Will get analysis of electricity cost of keeping lights on.

Zoning ñ M. Kalalian

1)1640 South Broad Street ñ Hometown Hostel Application has been made to use this property as a hostel and get variance, as property is currently zoned R10-A, which is single-family residence. Area civic associations, including EPX, oppose this use. A special ZBA hearing on this property is scheduled for 1/21/09, 5 pm.

2)1728 East Passyunk Avenue (formerly TEN store) Application filed for an optical shop at this address has been withdrawn. However, the property is still being purchased by same party who desired the optical store.

3)1726 South 13th Street (@ Castle) Owner wants permission to make this a two-dwelling property, despite EPX's past zoning meeting w/owner wherein neighbors expressed disapproval of a multi-family dwelling at this address. We suspect that owner is housing more than one family there presently, despite not having requisite variance. EPX will ask owner to appear again before our zoning committee.

4)1712 South 10th Street ñ Bella Rosa II Hearing before ZBA on 9/24/08, and they will vote on it this week. EPX board to meet after tonight's meeting to decide whether EPX will ultimately support this. Prospective buyer, Jonathan Klein, wants variance to allow for dining on second floor of the building.

5)Fox Electric Site ñ Emily and 12th Street Status quo: Johnny Chang met with the community in July and presented preliminary plans for seven rowhouses on Emily and 12th Street. He has since revised plans and decided to build three-story dwellings without garages on the three 12th Street houses; Emily Street houses to be two-story dwellings. EPX is pleased that Chang wishes to transform site to residential properties; however, EPX has communicated to Chang that there are a number of concerns that need to be addressed before EPX can support the project, including: need for demolition of existing structure; fire alleys; compliance w/building and fire codes for windows in sleeping rooms; very small bedrooms without closets in the two-story plans; no indication for laundry equipment. EPX has asked for opportunity to review complete architectural renderings and elevations.

6)Barbershop @ 12th and Mifflin Per Joseph F. Marino, the business never got off the ground. Business owner did not get licensing, zoning. Sign has been taken down. Storefront still empty.

Old Business:

1)DCED Grant status ñ Still awaiting grant funds.

2)EPX Office Space ñ 1940 South 13th Street

Grand opening was a success. EPX board members donated lots of time, hard work, money, and items to get office ready.

3)Film Festival - EPX Stories (per M. Kalalian)

Component 1, children's film-making workshop at Free Library at Broad and Morris, was a success. Fifteen area children, ages 7 to 13, participated and had opportunity to try out film-making equipment.

Component 2, senior citizens @ SPOAC storytelling, was a success. Film festival trailer was created from interviews w/senior citizens, many of whom had more they wanted to say.

Component 3, which is most ambitious, the call for entries to independent filmmakers, needs an extra push. We haven't received the response we hoped for and may have to extend the entry deadline to later in the fall or perhaps relaunch the event in spring of '09.

2)SWEAT GYM: EPX welcomed John (trainer) and Nicole (attendant) of our good business neighbor Sweat Gym. Class schedule and free passes to gym were distributed to meeting attendees. We learned that:

The company is 12 years old, has 8 locations throughout Delaware Valley. Membership includes two hours of free personal training, admission to all Sweat locations.

Many health insurance plans will cover membership.

Besides free weights and cardio equipment stations w/TVs, many classes are offered, including just-added spin classes.
